ADMINISTRATIVE REPORT OF THE COMMISSIONER GENERAL OF EXCISE FOR THE YEAR 2009

Introduction

The Department of Excise comes under the purview of the Ministry of Finance and Planning. It has the legal authority for the implementation of the excise policies of Government and relevant activities including the protection and collection of excise revenue, principally under the Excise Ordinance (Chapter 52 of the Legislative Enactment). In addition, the authority and responsibility for administration of the Tobacco Tax Act No. 08 of 1999, the collective responsibility for the enforcement of Poisons, Opium and Dangerous Drugs Ordinance with the Police and other relevant Agencies and the responsibility of effecting of National Authority Act No.27 of 2006 on Tobacco & Alcohol are also mandatory functions delegated to the Department. The Department also acts as a principal agency holding the authority for the enforcement of provisions of the above Ordinances, Acts and consequential rules and regulations, notifications, orders and directives. The Department is engaged in performing a national mission providing social security by collecting considerable amount of revenue to finance the country's economic development as well as by preventing and detecting illegal activities of every description falling under the above legislations.

2. VISION:

Building of a healthy society in Sri Lanka, which is free from illicit liquor and narcotic drugs.

3. MISSION:

Efficient and effective administration of the liquor and the tobacco industry in Sri Lanka through the collection of revenue and prevention of illicit manufacture and sale of such products, for development and welfare of the society, and the enforcement of the Poisons, Opium and Dangerous Drugs Ordinance for the social protection of Sri Lanka.

Objectives:

- a. The collection and protection of revenue from liquor and tobacco.
- b. The enforcement of the Excise Ordinance and the Tobacco Tax Act.
- c. The effecting of the Poisons, Opium and Dangerous Drugs Ordinance.
- d. The effecting of National Authority Act on Tobacco and Alcohol.

Functions:

- a. Supervision and control of Licenced premises, and collection of revenue there from.
- a. Acting as the law enforcement agency in respect of the Excise Ordinance.
- c. Enforcement of the Tobacco Tax Act including supervision and control of tobacco manufactories.
- d. Acting as a law enforcement agency in respect of the Poisons, Opium and Dangerous Drugs Ordinance.
- e. The effecting of National Authority Act on tobacco and alcohol.

8. IMPLEMENTATION OF POLICIES:

The present excise policy is based on the policy frame of "Mahinda Chinthanaya." The Excise Department takes necessary action to control the consumption of liquor and the use of cigarettes. The taxes for liquor were constantly increased in order to decrease the consumption. The issuance of new liquor Licences have been limited only for the Tourist Board approved Hotels.

The Department levied a tax of Rs 200/= per Ltr for the issuance of spirits, for local industries and Rs 100/= per Ltr for export productions. Accordingly, a revenue of Rs 468.0 Mln has been earned as taxes, in favour of issuing of spirits during the year 2009..

When issuing an application for a liquor Licence, a sum of Rs 7500/= should be paid, and a sum of Rs 100,000/= be charged for shifting of excise Licence to another premises. Besides, Rs. 500,000/= for transferring of FL 04 Licence to another person, and Rs 150,000/= be charged for others. Accordingly, the total revenue collected in the year 2009 from those sources were Rs 114.0 Mln.

10. INTERNAL AUDIT UNIT:

The Internal Audit Unit is in operation under direct supervision of the Commissioner General of Excise, with a Deputy Excise Commissioner and two Public Management Assistants. Based on the action plan prepared for the Unit, auditing were carried out to achieve the departmental objectives through the following fields:-

- ➤ Collection of revenue under Excise Ordinance.
- > Development of Human Resources
- > Introduction of Information Techlogy
- ➤ Effecting of Tobacco Tax Act
- > Financial Management

Management of Vehicles and other assets.

Linking all above fields, auditing were carried out with regard to Receipts, Supplies, payment vouchers, cost registers in relating to 105 vehicles, aiming at all Receipts, Payments, Supplies, Services and Assets Management in relating to Excise Head Office. Also, auditing were made at Excise Stations, Excise Superintendents' offices, Assistant Excise Commissioners' offices, including 14 sub offices, Manufactories, Distilleries, Warehouses and Toddy Manufactories, under annual audit programme in 2009. The Unit has identified some irregular advises issued against the Excise Ordinance, Excise Notifications, Financial Regulations and Establishment Code, and introduced suitable metholodigies to avoid such irregularities.

03 Audit and Management Committee meetings were assembled under the leadership of the Commissioner General of Excise, with the participation of all Staff Officers in the Head Office during the year 2009, and decisions were taken to effect the decisions taken at the Audit & Management Committees of the Ministry, through the all Staff Officers. Observations and difficulties raised from Internal Audit Quaries were also discussed.

By all these programmes, this Unit was able to give successful coverage to reach at the tagets and objectives of the Department.

11. BOARD OF SURVEY:

By the end of 2009, all Board of Surveys in relation to year 2008 were completed.

35. FUNCTIONS OF SPECIAL OPERATION BUREAU (S.O.B)

a. Colombo Unit

This Unit has been under the purview of the Commissioner General of Excise. This Unit consists of 01 Superintendent of Excise, 07 Excise Inspectors including an Excise Officer In-charge, and 21 other officers.

This Unit bears the responsibility of curbing all excise crimes in all areas, inquiring the complaints received by the Commissioner General of Excise from Public. The number of detections made by this Unit is 2060. Details are given below:-

During the year 2009, a sum of Rs 12,752,650/= was recovered from the raids conducted by this Unit. A sum of Rs 18,166,138/= was recovered from offences committed in 602 Licenced premises. Accordingly, a total sum of Rs 30,918,788/= collected as Govt income during the year 2009.

The Officers of this Unit managed to detect 262 grms of Heroin, 289 Kgs of Ganja, and 05 High Court cases were filed against these detections. Also, 34 ½ acres of Ganja (06 Ganga Chenas) were destroyed.

b. Central Province Unit

This Unit has been under the purview of the Commissioner General of Excise and supervised by the Assistant Excise Commissioner (Central Province). Unit consisted of an Officer Incharge, 04 Excise Inspectors, an Excise Sergeant, 07 Excise Guards, 01 Female Excise Guard and an Excise Driver. The Unit was established in 2003 and covered special duties in islandwide.

Through 1505 raids conducted, 1505 personnel were taken into custody during the year 2009, and a sum of Rs. 10,052,150/= was recovered as fines. 142 unlawful distillation points were raided.

439 Licenced premises were detected for violating the conditions in 05 Provinces in the island, and 439 Technical Crime Reports were forwarded. Rs 9,843,925/= were earned as composition fees.

c. Southern Province Unit:

This Unit has been under the the Commissioner General of Excise, with the supervision of Assistant Excise Commissioner (Southern Province). The Unit was consisted of an Officer Incharge, 03 Excise Inspectors and 05 Excise Guards. 740 detections were carried out by this Unit, and earned Rs 1,820,500/= as Courts fines and Rs 517,350/= were collected as composition fees from 37 Technical Crime Reports.

d. North-Western Province Unit

Under the supervision of the Commissioner General of Excise, this Unit has been administered by the Assistant Excise Commissioner (North-Western Province) It comprises of 03 Excise Inspectors, 01 Excise Sergeant, 01 Excise Corporal and

04 Excise Guards. During the year under review, this Unit has carried out 841 detections and filed 764 cases against the culprits. Rs. 5,149,650/= were recovered as Court fines, and have managed to detect 70 mg of Heroin under the Dangerous Drugs Ordinance and Rs. 10,000/= was collected as fines.

36. ACTIVITIES OF THE MANUFACTURING OPERATION UNIT AND ITS PROGRESS

Under the control of the Commissioner General of Excise, this Unit has been guided by an Assistant Excise Commissioner. The Staff consisting of a Chief Excise Inspector, 01 Excise Inspector, a Female Excise Corporal, and an Excise Driver. In addition, an Excise Inspector is attached to Greyline Custom Yard at Orugodawatta to monitor the matters relating to importation of spirits, when required.

The main functions of this Unit are the supervision of Distilleries, Liquor Manufactories, Toddy & Wine Manufactories, Liquor Wholesale Licenced places (FL 03) established island wide and collect excise revenue. The Officers attached to this Unit, inspect these places regularly and submit Technical Crime Reports if they found any offences occurring in these places. They also provide advises to these Establishments regarding the excise rules and regulations and keep them under close supervision.

138 Technical Crime Reports have been forwarded for the offenses of the Licenced premises through supervision, during the year 2009 and Rs. 5,295,500/= has been collected as composition fees. This Unit closely monitored the Licenced manufacturing establishments in order to achieve the targeted revenue.

Also, this Unit assist to maintain the statistics, and making policy planning in relating to Liquor Manufactories, on behalf of the Department.

37. ACTIVITIES OF THE NARCOTICS UNIT:

The Narcotic Unit which has been established for the enforcement of law under the Poisons, Opium and Dangerous Drugs ordinance is in operation at D.R Wijewardena Mawatha, Colombo 10. This Unit operates under the supervision of a Superintendent of Excise with an Officer Incharge, and 20 other officers.

808 detections were carried out during the year 2009 and 730 males and 73 females were taken into custody. Out of the 808 detections, 641 were connected to Heroin, 160 were connected to Ganja detections. There are 23 cases Canabis plantation cases and 83 cases filed in High Courts. . Total revenue collected from Court fines were Rs $4{,}094{,}300/=$.

38. EXCISE CRIMES:

The number of raids conducted in the year under review was 45737 and Rs 196,313,030/= were recovered as Court fines.

This includes, 38965 excise crime detections, 4280 narcotic detections, 1237 detections under the Tobacco Tax Act, and 1255 detections under the National Authority on Tobacco & Alcohol Act.

39. ASSAULTS & OBSTRUCTIONS

An Excise Inspector who attached to the Excise Station, Kegalle was hospitalized due to an assault by the suspect. Case has been filed against the suspect at Magistrate Courts, Kegalle and case is still on warrant.

CONCLUSION

The excise revenue collected during the year under review was Rs 28,516 million, and that was an increase of 4% compared to year 2008. Reason for the slower increase of revenue was due to the drop in consumption of liquor. Comparing to the year 2008, it shows that 10% and 3% decrease in production of hard liquor and soft liquor respectively. Though, the production of liquor has come down, the excise revenue was slightly increased, due the increase of taxes. When perusing the figures of liquor productions, it is revealed that in past years, the production has been increased by year and year, but since 2008, it was dropped due to the new policy adhered from 2005. The Department conducted 45737 raids in 2009. This was a decrease of 19%, than previous year. Reason for this was that, as we organized some mass detection programmes to evacuate illegal liquor, it is numeritically shows a drop of detection figures, but, qualitatively these detections were much better. Accordingly, I am pleased that we have been successful in fulfilling our objectives during the year under review,

I am thankful to His Excellency the President, the Hon Minister of State Revenue & Finance and Deputy Minister of Finance & Planning, and the Secretary to the Ministry of Finance for giving me the strength, directions and guidelines to carry out my duties through continuous review of our activities, and to the Deputy Secretaries to the Treasury who cleared the hindrances by co-ordinating and constantly giving instructions. I also wish to thank the Additional Secretary and all other officers and the staff of the Ministry of Finance, who assisted us in this task.

Also, I am grateful for the assistance extended to me by the District Secretaries and the Divisional Secretaries to perform our functions of the Department properly. I also wish to thank and extend my gratitude to the National Dangerous Drugs Control Board, Attorney General's Department, Police Department, Government Analyst Department, National Authority on

Tobacco & Alcohol and other Govt Institutions for the friendly assistance offered to the Department to achieve its goals.

I express my gratitude to Sri Lanka Institute of Development Administration (SLIDA) the Institute of Govt Accounts & Finance (INGAF), the Human Rigths Commission, Bribery Commission, and the Sri Lanka Foundation Institute, for providing training opportunities and enhance the knowledge, skills and attitudes of the Department officers.

Also, I specially thank for the support extended to this Department by the Director and Staff of Fiscal Management Reform Programme (FMRP) which is funded by the Asian Development Bank, in giving opportunities for overseas trainings.

Finally, I extend my special thanks and gratitude to my dedicated and courageous staff from every grades who contributed to the success of the Department.
