INTRODUCTION

The Department of Excise operates under the purview of the Ministry of Finance and Planning. It has the legal authority for the implementation of the excise policies of the government and relevant activities including the protection and collection of excise revenue, principally under the Excise Ordinance (Chapter 52 of the Legislative Enactment). In addition, the authority and responsibility for administration of the Tobacco Tax Act, No. 08 of 1999, the collective responsibility for the enforcement of Poisons, Opium and Dangerous Drugs Ordinance with the Police and other relevant agencies and the responsibility of effecting of National Authority on Tobacco & Alcohol Act, No.27 of 2006 are also mandatory functions delegated to the Department. The Department also acts as a principal agency holding the authority for the enforcement of provisions of the above Ordinances, Acts and consequential rules and regulations, notifications, orders and directives. The Department is engaged in performing a national mission providing social security, by collecting a part of government revenue to finance the country's economic development as well as by preventing and detecting illegal activities of every description falling under the above legislations.

2. VISION:

Building of a healthy society in Sri Lanka, which is free from illicit liquor and narcotic drugs.

3. MISSION:

Efficient and effective administration of the liquor and the tobacco industry in Sri Lanka through the collection of revenue and prevention of illicit manufacture and sale of such products, for development and welfare of the society, and the enforcement of the Poisons, Opium and Dangerous Drugs Ordinance for the social protection of Sri Lanka.

Objectives:

- a. The collection and protection of revenue from liquor and tobacco.
- b. The enforcement of the Excise Ordinance and the Tobacco Tax Act.
- c. The implementation of the Poisons, Opium and Dangerous Drugs Ordinance.
- d. The implementation of National Authority Act on Tobacco and Alcohol.

Functions:

- a. Supervision and control of Licensed premises, and collection of revenue there from.
- b. Acting as a law enforcement agency in respect of the Excise Ordinance.
- c. Enforcement of the Tobacco Tax Act including supervision and control of tobacco manufactories.
- d. Acting as a law enforcement agency in respect of the Poisons, Opium and Dangerous Drugs Ordinance.
- e. The implementation of National Authority Act on tobacco and alcohol.

6. Human Resource Development

This Division operates under the supervision of the Excise Commissioner (Administration / Human Resources) and consists of a Deputy Excise Commissioner, 01 Female Excise Sergeant Major, 01 Excise Corporal, 01 Excise Driver Corporal and 01 Public Management Assistant.

The main objectives of this division are to organize various training courses in order to develop the knowledge and the attitudes of Departmental Officers, and to refer officers for local & foreign training courses. This Unit was able to complete the programme launched with regard to the court duty training & Competition successfully during the year 2013. Further, 1059 licences were operated under Tobacco Tax Act in 2013 and it was expected to prepare and publish the new notification including new regulations.

8. IMPLEMENTATION OF POLICIES:

The present excise policy is based on the policy frame of “Mahinda Chinthanaya”. Accordingly, the Excise Department takes necessary action to control the consumption of liquor and the use of cigarettes. Also, as an action to curtail down the consumption of liquor, the taxes for Liquor were increased several times. Issuance of new liquor licenses has been restricted only for the institutions approved by the Sri Lanka Tourism Development Authority. Section 15 of Excise Ordinance was amended by Amendment Act, No.07 of 2013 to give effect that licence required for tapping coconut trees was abolished. Amendments were proposed to resolve the difficulties faced in implementing the National Authority Act on Tobacco and Alcohol, and steps have been taken to amend the National Authority Act on Tobacco & Alcohol. Preventing Villages from intoxicating substances Programme was initiated to contribute “*Mathata Thitha Programme*” actively and more than 255 such villages were made prevention villages in the first phase.

9. EXCISE TAX STRUCTURE:

The Department revised the rate of duty of issuing spirits for local industries by the Excise Notification 956 published on 05.10.2012. According to that Notification, following Excise Duties have been levied.

Rs. 370/= per bulk litre upto 10,000 litres per month

Rs. 470/= per bulk litre from 10,001 to 20,000 litres per month

Rs. 720/= per bulk litre above 20,000 litres per month

However, duty was imposed on spirit when supplying locally as well as the importation by the Excise Notification 957 with effect from 04.04.2013. The duty charged on local purchase/ import of spirit (Ethyl Alcohol). is charged as a Withholding Tax which is allowed to be set off against the Excise duty payable on liquor manufactured using such spirits.

By the Excise Notification 957, duty was imposed from 04.04.2013 as follows;

When issuing / renewing an application for a liquor Licence, a sum of Rs 7500/= is levied. A sum of Rs 100,000/= is charged for shifting an Excise Licence to another premises. Besides, Rs. 1,500,000/= is charged for transferring of FL 04 Licence to another person, and Rs 200,000/= for other types of licence transfers. Accordingly, the total revenue collected in the year 2013 from those sources were Rs. 243 million.

10. INTERNAL AUDIT UNIT

The Internal Audit Unit is in operation under direct supervision of the Commissioner General of Excise and auditing was carried out according to the Audit Plan based on the Action Plan of the Department.

In 2013, Offices of Superintendent of Excise and Excise Stations situated in the districts of Kalutara, Galle, Matara, Anuradhapura & Polonnaruwa and Offices of Assistant Commissioner of Excise situated in the Western Province -11, Southern Province & Northern

Province have been audited. Through these functions it helped to achieve aims and targets of the department.

11. BOARD OF SURVEY :

Board of Surveys of all the offices of Assistant Commissioners of Excise and Superintendent of Excise, Bureaus of Special Operations, Excise Stations, Warehouses and Manufactories in relation to the year 2013 are being carried out.

12. EXCISE TAX IN ARREARS :

In case of Globe Blenders, Wayamba Distilleries Company and Wayamba Wholesale Store, agreements were signed under support and supervision of Attorney General's Department in order to collect the tax arrears from these organizations. According to Such agreements Rs. 157,459,193.42 has been charged as the income arrears in Excise tax during 2013.

13. AUDIT QUERIES:

20 Audit Queries were received during the year 2013 and all were answered. The queries were on vehicle repairs, bank reconciliation, purchasing of uniform materials, reward fund account, government revenue, construction of buildings, purchases and government officers advance account.

37. FUNCTIONS AND PROGRESS OF CRIME DIVISION

This unit is administrated by a Deputy Commissioner of Excise (Crime) under the purview of Commissioner General of Excise. Two Excise Inspectors, one Female Inspector, One Excise Guard and an Excise Driver were attached to this unit.

16 Excise offices, 14 Bottled toddy manufactories and 06 liquor manufactories were examined during the year 2013. It instructs Excise Stations and B.S.O.s island wide to maintain properly and in a disciplinary manner. Also, it mobiles all the officers at provincial level and review raids quarterly to achieve targets.

Weekly reports from Assistant Commissioners of Excise and Superintendents of Excise were called and supervised them to achieve goals of the Department.

It directly supervised B.S.O. - Colombo and Narcotic Bureau which operate island wide.

Further, in year 2013 Licenced Premises in various parts of the country were examined and 252 Technical Crime Reports were submitted and Rs. 14,769,708/= was earned as composition fees. Also, Rs. 2,433,050/= was to be earned by unsettled Technical Crime Reports.

It has taken actions to minimize warrants island wide in the year 2013 and earn a large amount of court fines to the government. Not only directing the department towards expected revenue targets but also, it has taken steps to uplift the welfare of the public by supervising discipline of the officers.

38. FUNCTIONS AND PROGRESS OF THE LEGAL AND STATISTICAL UNIT

This Unit had been consisted of an Assistant Excise Commissioner, 02 Chief Excise Inspectors, three Excise Inspectors, one Female Excise Sergeant, and an Excise Driver and functioned up to June 2013.

During that period it was operated under the direct supervision of the Commissioner General of Excise. Then, the scope of this unit were maintaining the statistics on tax income relating to liquor manufactories, warehouses, distilleries & bottled toddy manufactories , referring documents to Hon. Attorney General relating to unlawful drug raids conducted island wide and maintaining & updating the files relating to court cases filed by licensees and department officers. Further, it had handled custom clearance and relevant correspondence in importing spirits from abroad.

The scope of this Unit has been changed after June 2013 and limited only to Law and Statistics.

This also came under the direct supervision of the Commissioner General of Excise and two Excise Inspectors and one Female Excise Sergeant were attached to this Unit. The scope of this Unit is to refer relevant cases to Hon. Attorney General relating to unlawful drug raids conducted island wide and to coordinate court cases with the Attorney General's Department which are filed by licensees and department officers and to update & assist the Commissioner General of Excise on all legal matters. Further, it also maintained data files relating to detections made by island wide Excise Stations.

39. BUREAU OF SPECIAL OPERATIONS – (Colombo)

This Unit has been functioning under the supervision of the Commissioner General of Excise & Deputy Commissioner of Excise (Crime) and under the control of the Superintendent of Excise, consisted of two Chief Excise Inspectors , 05 Excise Inspectors ,and sixteen(16) officers of other ranks.

This Unit bears the responsibility of curbing all excise Crimes in all areas, inquiring the complaints received by the Commissioner General of Excise from the public. This Unit was also assigned the responsibility of detecting the offences occurred in illegal places as well as licensed places.

Under this, following Court Fines and Composition fees were charged during the year 2013.

Upon the receipt of public complaints to the Commissioner General of Excise in 2013, this unit was able to successfully detected the places of distilling spirit in large quantity and many foreign liquor illegal businesses including large quantity of foreign liquor illegal businesses by using Internet. In total, year 2013 could be considered as a successful year for this Unit.

40. BUREAU OF SPECIAL OPERATIONS – (Southern Province)

This Unit has been functioning under the supervision of Assistant Excise Commissioner (Southern Province). 04 Excise Inspectors including Southern Province Officer in Charge, 01 Excise Sergeant , 04 Excise Guards and 02 Excise Drivers have been attached to this unit from 01.01.2013 to 31.12.2013 and Southern Province Assistant Excise Commissioner's driver also reported to this Unit.

According to the circular issued in the year 2013 the target number of detections given was 840 (based on the number of officers) and it was limited to 845 detections. Out of this, the number of settled cases was 756. Fine earned proportionately was 3,959,700/=.

There were 33 warrants, 01 pending case, 04 other cases and 55 unsolved cases by the end of the year. The composition fee for 01 Technical Crime Report was Rs. 12,500/=. Mass raids were carried out by excise officers including B.S.O. Southern Province covering Hikkaduwa, Nawagathakolaya, Thotagamuwa, Malawenna, Akuressa, Athuraliya, Tissamaharamaya, Warayaya, Uswewa, Matara, Morawaka, Deniyaya, and Kamburupitiya.

41. BUREAU OF SPECIAL OPERATIONS - (Central Province)

This Unit has been come under the purview of the Commissioner General of Excise and the supervision of the Assistant Commissioner of Excise (Central Province) and under the guidance of Officer-in-Charge. One Chief Inspector of Excise, 06 Excise Inspectors, 01 Excise Sergeant Major, 02 Excise Sergeants, 09 Excise Guards, 01 Female Excise Guard and 01 Excise Driver were served in this Unit in 2013.

This Unit has been served since 2003 and covered special duties island wide. In 2013, 1512 detections were carried out and 1512 persons were arrested and after they were produced to courts, Rs. 9,250,800.00 was collected as fines. 12 persons were arrested under Poison, Opium and Dangerous Drugs Ordinance and a considerable amount earned to government as fines. Also, 03 Detections were carried under the Tobacco Tax Act.

This Unit which covers all the provinces in the island, submitted 500 Technical Crime Reports and earned Rs.6,773,625.00 as composition fees.

This unit shows an overall progress compared to the year 2011.

42. BUREAU OF SPECIAL OPERATIONS - (North-Western Province)

Under the supervision of the Commissioner General of Excise, this Unit has been administered by the Assistant Excise Commissioner (North-Western Province - I). One Chief Inspector of Excise, 06 Inspectors of Excise, 02 Excise Sergeants, 01 Excise Corporal, 06 Excise Guards, and one Excise Driver were attached to this Special Operation Bureau.

In 2013, 1102 detections have been carried out and out of this 1030 cases were settled and fine earned proportionately was Rs. 4,859,050.00.

By the end of the year, number of unsettled cases were 72 including 60 warrants and 12 pending cases. Mass raids were carried out covering Kurunegala and Puttalam Districts. 90 Technical Crime Reports have been submitted and Rs. 2,484,421.00 was collected as composition fees.

43. FUNCTIONS AND PROGRESS OF THE NARCOTIC UNIT

The main Act which ensuring social protection of the Excise Department is the Poisons, Opium and Dangerous Drugs Ordinance. Narcotic Unit was established in 1985 by giving effect powers to implement such Act throughout the Island.

This Narcotic Unit has been come under the supervision of the Commissioner General of Excise and the Deputy Commissioner of Excise (Crime) and under the control of Superintendent of Excise. One Chief Excise Inspector, 05 Excise Inspectors , 01 Excise Sergeant Major, 01 Female Excise Sergeant Major, 02 Excise Sergeants, 01 Female Excise Sergeant, 13 Excise Guards and 02 Excise Drivers were attached to this office in 2013.

876 raids were carried out in 2013 and out of this 27 Cases have been filed in the High Court. In addition, 529 offences relating Heroine and 321 offences relating Ganja were carried out. Amongst arrested persons, there were 744 males and 102 females. By the end of the year 2013, Rs.5.34 million was charged as fines from settled cases.

During the year 2013 in two major raids, it was able to arrest two Pakistan citizens with 02 Kgs of Heroine, who had hid heroine into fruit tins and brought to Sri Lanka in large quantity.

44. INFORMATION & TECHNOLOGY UNIT

This Unit has been under the direct supervision of Deputy Excise Commissioner (Human Resource). The Unit was consisted of an Officer-in-Charge, 01 Excise Inspector, an Information Technology Assistant, 01 Female Excise Sergeant, and 01 Excise Guard.

The main role of this Unit was to link the provincial offices with the Excise Head Office to obtain information and to update the Departmental Website (www.excise.gov.lk) Also, this Unit trains officers in ICT and resolves computer problems and makes recommendations when purchasing computer components.

Providing computers to each and every Excise Station under the programme of networking Excise Stations which started from 2012 was completed. Accordingly, under the coordination of the Information Communication Technology Agency (ICTA), programme of networking Excise Stations was being proceeded successfully.

Under the programme of computerizing the licences division, activities of the licences division were computerized in the year 2013 and were being carried out effectively.

CONCLUSION

Year 2013 was the beginning year of second centenary for the Excise Department. Rs. 66008 million has been collected as excise duties during the year 2013. It was an increase of 10% in comparing with 2012. However, the hard liquor production in 2013 showed a decrease of 11% in comparing with 2012. The soft liquor (beer) production showed an increase of 21% over the year 2012. 32881 excise raids have been carried out by the department during the year under review.

It has been observed that illicit liquor and illicit drugs cannot be controlled only through detections and a programme of Prevention of Villages has been commenced from 2010 with the people's participation at the village level. We were able to absorb 255 villages into the programme of Prevention of Villages by 31.12.2013. This programme had also been carried out during the years of 2011 & 2012 and villages absorbed during such period were maintained so in the year 2013 as well.

I am thankful to His Excellency the President, the Hon. Deputy Minister of Finance & Planning, and the Secretary to the Ministry of Finance and Planning for giving me the strength, directions and guidelines to carry out my duties through continuous review of our activities, and to the Deputy Secretaries to the Treasury who cleared the hindrances by coordinating and constantly giving instructions. I also wish to thank all other officers and the staff of the Ministry of Finance and Planning, who assisted us in this task.

Also, I am grateful for the assistance extended to me by the District Secretaries and the Divisional Secretaries to perform our functions of the Department properly. I also wish to thank and extend my gratitude to the National Dangerous Drugs Control Board, Attorney General's Department, Police Department, Police Narcotic Bureau, Customs Department, Government Analyst Department, National Authority on Tobacco & Alcohol and other Govt. Institutions for the friendly assistance offered to the Department to achieve its goals.

I express my gratitude to Sri Lanka Institute of Development Administration (SLIDA), the Human Rights Commission, National Dangerous Drugs Control Board, Sri Lanka Foundation Institute and Ratmalana Sir John Kotalawala Defence University for providing training opportunities and enhance the knowledge, skills and attitudes of the Departmental officers.

Finally, I extend my special thanks and gratitude to my dedicated and courageous staff from every grades who contributed to the success of the Department. Also, I expect the assistance of all the officers to achieve the goals of the Department effectively during the year 2014.
